MINUTES OF THE BYLAWS AND POLICY COMMITTEE MEETING NOVEMBER 19, 2019

1) Call to Order

5) New Business:

a. Review and recommend the Drug Free Workplace Policy in the Personnel Handbook

Discussion: Policy changes are proposed to reflect the legalization of recreational cannabis in Illinois on January 1, 2020. Proposed changes are from HR Source's sample policy. The new policy states that Library employees cannot be under the influence of cannabis while at work. There was discussion of the section that says: "No employee shall be under the influence of alcohol while on library premises or while performing library business off premises. A moderate amount of alcohol may be consumed at approved events where the employee is representing the library provided such consumption does not adversely affect an employee's behavior or judgment and, if the employee will drive a motor vehicle following the event, does not adversely affect the employee's ability to safely and legally drive the vehicle. A violation of this moderate consumption rule will result in discipline up to and including termination of employment." Coen will provide guidelines to staff with examples of occasions where moderate alcohol consumption is permissible. There was also discussion about the following statement under the "legal drugs" section: "Employees should not, however, disclose underlying medical conditions unless specifically directed to so." Coen will revise this sentence to clarify the meaning and bring to Board again in December.
