MINUTES OF THE REGULAR MEETING OF THE LIBRARY BOARD OF TRUSTEES FEBRUARY 18, 2020

1) Call to Order

The meeting was called to order at 7:01p.m. by Board President Jason Fichtel on Tuesday, February 18, 2020 at the Westmont Public Library.

2) Roll Call

Present: Trustee Heather Booth, Trustee Elaine Carmichael, Secretary Annie Delano, Vice President John Martens, Treasurer Kerry O'Connor, Trustee Rajesh Parikh, and President Jason Fichtel.

Absent: Treasurer O'Connor

Staff present: Director Julia Coen, Assistant Director Brittany Smith, and Administrative Assistant Julie Olsen

3) Pledge of Allegiance

Treasurer O'Connor arrived at 7:02p.m.

4) Approval of Consent Agenda

Motion: Martens moved to approve the Consent Agenda, Delano seconded.

Discussion: Trustees appreciated the revised format of the Director's Report. Trustee Parikh asked for clarification as to the difference between the digital branch and the website visits, and why the number of digital branch visits are declining. Coen and Smith stated that patrons are able to access digital branch materials directly from the digital app without going through the Library's digital branch. Visits to the digital branch have declined but there has been an increase in the number of digital checkouts.

e. Discussion of the FY21 draft budget

Discussion: Coen stated that this is a first draft, there will be additional changes which will lead to a balanced budget and presented the budget in line by line detail. There is approximately \$16,000 less in revenue than in expenditures. This is mostly due to the increase of \$10,000 designated for special reserves and a reduction in fines and fees revenue. Trustees noted that the notes included with the draft were comprehensive.

11) Executive Session: According to 5 ILCS 120/2, the Board may move to go into executive session to discuss the appointment, employment, compensation, discipline, performance, or dismissal of specific employees to the public body or legal counsel for the public body, including hearing testimony on a complaint lodged against an employee of the public body or against legal counsel for the public body to determine its validity. However, a meeting to consider an increase in compensation to a specific employee of a public body that is subject to the Local Government Increase Transparency Act may not be closed and shall be open to the public and posted and held in accordance with this Act.
