MINUTES OF THE REGULAR MEETING OF THE LIBRARY BOARD OF TRUSTEES DECEMBER 14, 2021

1) Call to Order

The meeting was called to order at 7:01 p.m. by Board President Jason Fichtel on Tuesday, December 14, 2021 at the Westmont Public Library.

Discussion: Booth requested the January Director's report Snapshot of Statistics include a comparison of 2019, 2020, and 2021. Coen stated that she would do so, and that overall 2021 numbers are still below 2019's.

13) New Business:

a. Board to consider a motion regarding the reconsideration request for the title All Boys Aren't Blue

Motion: Booth moved to deny the request for reconsideration and retain the title All Boys Aren't Blue in the Young Adult Collection, O'Connor seconded.

Discussion: Krotiak asked which category the book is currently located in and what are the next older and next younger categories. Coen stated that it is currently located in Young Adult, the next older category is Adult and the next younger is Juvenile; staff are currently working to divide Juvenile into elementary and middle school grades. Coen further stated that Young Adult is designed for high school and above, or patrons aged approximately 14 and older. Coen responded that the book states in its introduction that it addresses sensitive topics, so that readers and their caregivers can determine the appropriateness for a specific reader. Krotiak asked how the librarians decide which category to place a

book in. Coen explained that there are several sources of information the librarians use: the book's publisher's recommendation, independent professional reviews of the book, and which category other libraries place the book in. Booth stated that based upon her reading of the book and her professional background, the book is appropriately placed in the Young Adult Collection based upon the language and style in which the book is written and the age of the individuals in the book. Booth also stated that other books that address puberty and sex in a manner appropriate for older teens are located in the Young Adult collection. O'Connor asked which age group Young Adult is targeted toward. Coen responded high school and older though there is a range of reading levels within the collection. This book is intended for older teens. Krotiak asked if a 10 year old would be able to check out the book. Coen responded, yes, as is the case with all books in the Library. Fichtel stated he also read the book, and as a college English professor, it is his opinion that structurally, linguistically, and culturally it is written for young adult readers; he believes it is an important book for whom it is written, and as such, it should be kept in the Young Adult Collection. Fichtel also reported that two patrons wrote emails to the Board in support of keeping the books in the Young Adult Collection. The Board did not receive any emails in support of the request to move the book to the Adult Collection.
