# MINUTES OF THE FINANCE COMMITTEE MEETING October 17, 2023

## 1) Call to Order

# a. Review and recommend the Fund Balance Policy

**Discussion:** Coen noted that the policy was last amended in 2015 and based on inflation costs since then she recommends a change to the minimum for the Special Reserves Fund to be increased to \$200K. Parker recommended a wording change so that "unrestricted" is used instead of "unreserved" in reference to the fund balance in the general fund.

# b. Review the capital outlay report and YTS renovation second phase

**Discussion:** The committee discussed the anticipated expenditures reflected in the report, Special Reserves balances, and the conceptual budget from Pathmann. Coen also mentioned the possibility of contracting with a consultant in the near future to do a capital outlay assessment to ensure we're appropriately planning for all facility issues for the next 10-15 years. The committee discussed if this should be done before the next phase of the renovation project is undertaken. Coen said she would get feedback from Treasurer O'Connor who is absent from the meeting tonight and share his thoughts.

## c. Review and recommend Payee Check Positive Pay

**Discussion:** Coen noted that the Village Finance department recommended we add this service to our checking account as an external control measure to prevent fraud. The committee discussed the service and agreed it was a good measure to take.

# d. Recommend the next finance committee agenda for February 2024

**Discussion:** Coen noted that in February the finance committee typically reviews the revenue sheet for the upcoming fiscal year and the salary schedule.
